This guide addresses high level and routine components of a grant application. It does not replace requirements outlined in the Notice of Funding Opportunity or Detailed Instructions required for any funding opportunity. The guide targets new or infrequent applicants to the USDA Forest Service but is available to all applicants for use.



Application Budget

- A **separate** Budget document must be created that clearly defines your project costs over the project period.
 - **Personnel (Salary Costs)**
 - **Fringe Benefits**
 - **Travel**
 - **Equipment**
 - **PLEASE NOTE:** The definition of equipment is tangible personal property having a useful life of more than one year and a per-unit acquisition cost of at least **\$5,000**.
 - **Equipment purchase is heavily discouraged.**



Application Budget

- **Supplies**
 - Tangible personal property other than equipment--includes tree purchase not completed under a contract for service
- **Contractual**
 - Contract for service, equipment rental
- **Other**
 - Sub-grants
 - Miscellaneous
- **Indirect Costs**
 - NICRA, de minimis, or none



Budget Narrative

- In a separate document titled “**Budget Narrative**”, explain and justify all requested budget items and costs.
- Please see the example in the Application Guide, along with Instructions **under the tab “FORMS, TEMPLATES & RESOURCES”**.

PLEASE NOTE:

- The Budget & Budget Narratives **MUST** match the **SF-424/424A**.
- All budget items must be consistent across the entire application.

Budget Narrative

- The **Budget** should be cited in the **Budget Narrative** document when the applicant is discussing the work to be performed and the cost to execute the specific work activity.
- For personnel salary costs, include the baseline salary figures and the estimates of time to be directly charged to the project. Describe any item that under the applicable Federal cost principles, requires the agency's approval and estimate its cost.
- The budget narrative **MUST** show the amounts and sources of match or cost share, including both cash and in-kind contributions.

SF-424/424A Application

- The SF-424 is an application for federal assistance that is required for grants.
- There is a budget information section that is required.
- Please make sure that any budget information in the SF-424A matches the Application budget as mentioned earlier.

Match: Cash Match vs. Third Party In-Kind

- **Cash** is dollar for dollar match- such as required expense paid by the grantee.
- **In-Kind** donations are non-cash contributions such as services, supplies, property, and equipment.
- All matching funds or in-kind donations **MUST** be necessary, reasonable, and allowable.
- A match **MUST** also follow FFA guidelines on how federal dollars can be spent.

Direct Costs vs. Indirect Costs

- If the cost can be identified specifically with a particular cost objective such as a grant, contract, project, function, or activity, then it is a **direct cost**.
- Costs of an organization that cannot readily be assigned to a particular project but are necessary to the operation of the organization and the performance of the project are considered **indirect costs**.

Indirect Cost Rates

- **De minimis**- The term “de minimis rate” refers to the rate that is available to recipients (and certain subrecipients) that do not have a current NICRA. The de minimis rate is **10%** of “modified total direct costs”.
- **NICRA**- Is an indirect cost rate over **10%** and must be negotiated through the Resource Audit Branch. You can find more information about negotiating your indirect cost rate in the appendix section of the Application Guide.

Supplies and Purchasing

- **Supplies**

- Tangible personal property other than equipment.
- This includes tree purchase not completed under a contract for service.
- Must be **under \$5,000**.
- Examples
 - Chainsaws, GPS devices, shovels, etc.



- **Equipment**

- Tangible personal property **over \$5,000**.
- **PLEASE NOTE** that equipment purchases are heavily discouraged and rental equipment should be considered first.
